REPORT OF BOARD

FINDINGS AND ORDER

1. This Supplemental Order is entered by the Board sua sponte as authorized by the Board at its hearing held at 9:00 a.m. on October 20, 1992, Board of Supervisors Room, Courthouse, Grundy, Virginia, and pursuant to authority granted to the Board's Chairman at the hearing of the Virginia Gas and Oil Board on June 16, 1992, at 9:00 a.m. at the Rhododendron Restaurant at the Breaks Interstate Park, Breaks, Virginia; and this Supplemental Order is being recorded for the purpose of (1) complying with the requirement of the Virginia Gas and Oil Board Regulations, 4 VAC 25-160.70C by supplementing the Order previously issued by the Board for subject Docket on March 22, 1990 and recorded at Book 264, Page 429 in the Office of the Clerk of Circuit Court, Dickenson County, Virginia on March 29, 1990 (herein "Board Order") to complete the record regarding elections. The Board Order pooled all interest in Subject Drilling Unit including those of the Respondents more particularly set forth and identified by the Designated Operator in the affidavits attached hereto and made a part hereof. The Board finds it has jurisdiction over the subject matter pursuant to the provisions of the Virginia Gas and Oil Act, § 45.1-361.1 et seq., Virginia Code, 1950 as amended.
2. Findings: The Board finds that:
 - (a) The Board Order provides that the designated operator hold, segregate and escrow funds which could not be paid by it either by reason of conflicting claims, uncertainty of title, or because the payee(s) were unknown or unlocatable or otherwise as required by Va, Code §§ 45.1-361.21 and 45.1-361.22;
 - (b) The Board has provided by regulation that the payment of funds statutorily subject to escrow be made in accordance with standards established by it (See Virginia Gas and Oil Board Regulation 4 VAC 25-160-90).
 - (c) Subsequent to the entry of the Board Order, the Board established standards for the escrow of funds which may differ from those established by the Board Order and the Board contracted with Premier Trust Company, c/o First Virginia Bank-Mt. Empire, P.O. Box 1038, Abingdon, VA 24210, or any successor named by the board to act as its Escrow Agent (herein "Escrow Agent");

- (d) Statutory compliance, administrative economy, consistency, centralized accounting and reporting and the limitation of escrow costs and fees are all factors which justify amendment of the Board Order to provide that funds subject to escrow pursuant to Va. Code §§ 45.1-361.21 and 45.1.361.22 (herein "Escrow Funds") be deposited with the Escrow Agent in accordance with current Board standards as set forth in this Order
 - (e) Current Board standards requiring the escrow of funds and the Board's agreement with its Escrow Agent, require the entry of a Supplemental Order establishing of record the elections made or deemed to have been made and specifying the sums or percentage thereof subject to escrow.
3. Order: By this Order, the Board orders the Designated Operator to tender, consistent with and in accordance with the findings set forth at paragraph 2. above and the annexed Affidavits, any funds subject to escrow pursuant to the provisions of Va. Code §§ 45.1-361.21 and 45.1-361.22 and instructs the Escrow Agent, to establish interest-bearing escrow account(s), IRS Tax Identification Number 54-1629506, in accordance with the information set forth in said affidavits to receive such funds and account to the Board therefore.
 4. Mailing of Order and Filing of Affidavit: The Designated Operator under the captioned Order or its Attorney shall file an affidavit with the Secretary of the Board within ten (10) days after the date of receipt of this Order stating that true and correct copy of this Order to each person whose interest or claim is subject to escrow and whose address is known.
 5. Conclusion: Therefore, the findings and all terms and provisions set forth above be and hereby are granted and IT IS SO ORDERED.
 6. Effective Date: This Order shall be effective on the date of its execution.
