NOTICE:

The Unit Operator gave notice to the Applicants that the Board would consider its disbursement petition at the November 15, 2011 hearing and consider whether to:

- (1) Amend the Pooling Order to provide for the disbursement of funds on deposit in the Escrow Account attributable to Tract 2 and a Portion of Tract 3 identified in the attached miscellaneous petition.
- (2) Delete the requirement that the Unit Operator place future royalties attributable to Tract 2 and those parties identified in the attached petition in Tract 3.
- (3) Continue the escrow account under this docket number.

FINDINGS: *Code of Virginia* § 45.1-361.22

Applicant has certified and represented to the Board that:

1. The owner of the coal estate for Tract 2 and 3 is Harrison-Wyatt, LLC for the subject drilling unit.
2. The owner of the gas estate for Tract 2 is Robert Russell Rash and for a Portion of Tract 3 are Willie Newberry, Roger Miller, Teresa McGlothlin and Sherrie Boyd for the subject drilling unit.
3. The above named parties have entered into a 50/50 CMB deed. Said deed allows the Applicant and Designated Operator to pay royalties directly to the persons identified in Exhibit EE annexed hereto and identified on Table 1 attached hereto.

RELIEF GRANTED:

1. **The Escrow Agent is ordered, to within ten (10) days of receipt of this executed order, disburse funds for the unit and applicants detailed in Table 1 attached as Page 3 of this order.**
2. **The Escrow Agent is ordered to Continue the Escrow Account for the Subject Drilling unit based on the attached Revised Exhibit E which replaces all prior Exhibit E's recorded for the Subject Drilling Unit.**

CONCLUSION:

Therefore, the requested relief and all terms and provisions set forth above be and hereby are granted **and IT IS SO ORDERED.**

APPEALS:

Appeals of this Order are governed by the provisions of the *Code of Virginia* § 45.1-361.9 which provides that any order or decision of the Board may be appealed to the appropriate circuit court and that whenever a coal owner, coal operator, gas owner, gas operator, or operator of a gas storage field certificated by the State Corporation Commission is a party in such action, the court shall hear such appeal de novo.


