REPORT OF BOARD

FINDINGS AND ORDER

1. This Supplemental Order is entered by the Board sua sponte in the form authorized by the Board at its hearing held at 9:00 a.m. on October 20, 1992, Board of Supervisors Room, Courthouse, Grundy, Virginia, and pursuant to authority granted to the Board's Chairman at the hearing of the Virginia Gas and Oil Board on June 16, 1992 at 9:00 a.m. at the Rhododendron Restaurant at the Breaks Interstate Park, Breaks, Virginia; and this Supplemental Order is being recorded for the purpose of (1) complying with the requirements of § 7.c of the Virginia Gas and Oil Board Regulations, VR 480-05-22.2 by supplementing the Order previously issued by the Board for the subject Docket on June 2, 1994 and recorded at Deed Book 780, Page 740 in the Office of the Clerk of the Circuit Court, Wise County, Virginia on June 14, 1994 and the Supplemental Order previously issued on October 26, 1994 and recorded at Deed Book 790, Page 658 in the Office of the Clerk of the Circuit Court, Wise County, Virginia on November 10, 1994 (herein "Board Order") to complete the record regarding elections. The Board Order pooled all interests in Subject Drilling Unit including those of the Respondents more particularly set forth and identified by the Designated Operator in the affidavits attached hereto and made a part hereof. The Board finds it has jurisdiction over the subject matter pursuant to the provisions of the Virginia Gas and Oil Act, § 45.1-361.1 et seq., Virginia Code, 1950 as amended.

This Amended Supplemental Order is being entered for the purpose of correcting Exhibit "B" attached to the Supplemental Order to indicate corrected Net Revenue Interests.

2. Findings: The Supplemental Order of the Board is hereby amended by amending Exhibit B attached thereto as follows:

(a) Exhibit B is deleted in toto and replaced with the Exhibit B attached hereto which has been amended to reflect the correct net revenue interests in the Hagan Estates for Tract 1, Mildred Horne, Earlene Lester and Rodney Lester, Karen Peters and Joseph Peters for Tract 3 and Peggy Sexton and Wilson Sexton for Tract 10.

(b) The Supplemental Order shall remain in full force and effect and is valid in all respects except as amended herein.

4. Conclusion" Therefore, the findings and all terms and provisions set forth above be and hereby are granted and IT IS SO ORDERED.
