REPORT OF THE BOARD

FINDINGS AND ORDER

1. Hearing Date and Place: This matter came on for further and final hearings before the Virginia Gas and Oil Board (herein "Board") at 9:00 a.m. on December 14, 1999 at the Dickenson Conference Room, Southwest Virginia Education 4-H Center, Abingdon, VA.
2. Appearances: James E. Kaiser, Esq. of the firm Wilhoit and Kaiser appeared for the Unit Operator; and Sandra B. Riggs, Assistant Attorney General, was present to advise the Board.
3. Jurisdiction and Notice: Pursuant to Va. Code § 45.1-361.1 *et seq.*, and in particular Va. Code § 45.1-361.21, the Board finds that it has jurisdiction over the establishment and maintenance of an escrow account for each of the conventional gas drilling units established by the Board through its pooling orders in the event that there are gas or oil owners whose identity and location remain unknown at the conclusion of the Board's hearing, and that the Unit Operator is required to deposit, as applicable, those funds specified in Va. Code § 45.1361.21.D into the applicable escrow account. Further, the Board finds that pursuant to Va. Code § 45.1-361.2 I.D, it has jurisdiction and authority to disburse funds on deposit in the escrow account which are to the interests of any unknown or unlocatable gas or oil owner from the Escrow Account to them, provided the identity and/or location of any such gas or oil owner who was unknown or

unlocatable at the conclusion of the Board's pooling hearing subsequently becomes known to the Board.

4. Prior Proceedings:

- 4.1 At the Board's Hearing on July 20, 1993 in Docket No. VGOB 93-0720-0388, the Board granted the relief brought by Equitable Resources Exploration, a Division of Equitable Resources Energy Company and entered its order on November 28, 1993, recorded in the office of the Clerk of the Circuit Court, Wise County, Virginia at Book 766, Page 398 (herein "Original Pooling Order"). At the Board's hearing on March 21, 1995 in Docket No. VGOB 95-0321-0495, the Board granted the relief sought by Equitable Resources Exploration, a Division of Equitable Resources Energy Company and entered its order on April 17, 1995 which was recorded on April 26, 1995 in the Office of the Clerk of the Circuit Court, Wise County, Virginia at Book 800, Page 331 (herein "Pooling Order") creating Subject Drilling Unit, naming the Unit Operator, and pooling the conventional gas interests in the Subject Drilling Unit for the production of gas other than occluded natural gas produced from all non-coalbed formations (herein "Conventional Gas") commencing at the surface to the total depth drilled of 5500 feet including, but not limited to all the Ravencliff, Maxon, Big Lime, Weir, Berea, and Upper Devonian Shale Formations (herein "Subject Formations") pursuant to Va. Code § 45.1-361.21. On August 24, 1995, the Board entered its Supplemental Order Regarding Elections incorporating the Unit Operator's Affidavit of Election which was filed on August 29, 1995 with the Clerk of the Circuit Court of Wise County, VA at Book 808, Page 528 (herein "Supplemental Order") to comply with the requirements of the Board's Regulation 4 VAC 26-160.70.C. by supplementing the Pooling Order to complete the record regarding elections and to identify to the Board those unknown and/or unlocatable claimants whose gas interest in Subject Drilling Unit were subject to the escrow requirements of Act and the Pooling Order. Randall Lee Woodruff has been identified by the Operator as an heir of Gladys Woodruff and Loma Woodruff whose 0.00002750 percent net revenue interest in the Subject Drilling Unit was deemed by the Pooling Order to have been leased under the terms of said lease became subject to the escrow requirements. Randall Lee Woodruff has been located, is no longer an unlocatable owner whose royalties must be escrowed, he resides at 3733 CR 513, Wildwood, FL. 34785, and is eligible to be paid all those funds theretofore deposited by the Unit Operator in the escrow account.
- 4.2 As instructed by the Board through the Pooling Order and the Supplemental Order, the Escrow Agent established the Escrow Account for Subject Drilling Unit (herein "Escrow Account"), and thereafter the Escrow Agent periodically received from the Unit Operator for deposit into the Escrow

Account proceeds which were designated by the Unit Operator through its royalty statements as being attributable to the gas interests of Gladys Woodruff and Loma Woodruff.

- 4.3 Unit Operator seeks disbursement to Woodruff of all funds currently on deposit in the Escrow Account for the Subject Drilling Unit, requests that the Unit Operator be relieved from its obligation to deposit any further sums attributable to Gladys Woodruff's interests in Tract 13 of the Subject Drilling Unit into the Escrow Account
5. Findings: The Escrowed Funds are comprised of the Principal deposited by Unit Operator into the Escrow Account, plus interest accruing on the Principal while on deposit in the Escrow Account, less Escrow Agent fees charged to the Escrow Account. According to the Unit Operator's Amended Affidavit of Election, Randall Lee Woodruff is no longer unknown and/or unlocatable and therefore is entitled to receive all of those sums heretofore deposited into the Escrow Account by the Unit Operator all of which are attributable to Woodruff's interests in Tract 13 of Subject Drilling Unit. According to the accounting filed with the Board by the Unit Operator, copy attached hereto, as of May 31, 1999 there was \$31.74 on deposit in the Escrow Account (herein "Accounting").
6. Relief Granted: The Escrow Agent is directed to disburse the Escrowed Funds to Randall Lee Woodruff by mailing to him a check in the amount of \$31.74, plus interest and less fees which accrue on said sum between the date of the Accounting and the date of disbursement from the V-2665 Unit's Escrow Account, to his residence at 3733 CR 513, Wildwood, FL 34785. Further, the Supplemental Order filed in this cause is hereby modified to: (1) identify Randall Lee Woodruff, (2) reflect that Woodruff resides at 3733 CR 513, Wildwood, FL 34785, and (3) delete the requirement that funds attributable to Woodruff's 0.00002750 percent net revenue interest in Subject Drilling Unit be deposited by Unit Operator into the Escrow Account. To the extent not specifically granted herein, any other or further relief requested by the Applicants in their application filed herein or in their objections to the accountings heretofore provided is denied.
7. Conclusion:

Therefore, the requested relief and all terms and provisions set forth in Paragraph 6 above be and hereby are granted and IT IS SO ORDERED.

8. Appeals:

Appeals of this Order are governed by the provisions of Va. Code § 45.1-361.9 which provides that any order or decision of the Board may be appealed to the appropriate circuit court and that whenever a coal owner, coal operator, gas owner, gas operator, or

operator of a gas storage field certificated by the State Corporation Commission is a party in such action, the court shall hear such appeal de novo.

9. Effective Date: This Order shall be effective on the date of its execution.
