REPORT OF THE BOARD
FINDINGS AND ORDER

1. **Hearing Date and Place:** This matter came on for final hearing before the Virginia Gas and Oil Board (herein "Board") at 9:00 a.m. on January 20, 2004 at the Southwest Virginia Higher Education Center on the campus of Virginia Highlands Community College, Abingdon, VA.
2. **Appearances:** Jill M. Harrison, Esquire appeared for the Unit Operator; and Sharon M.B. Pigeon, Assistant Attorney General, was present to advise the Board. Randall Asbury, Jeff Kein and Michael Pryor also appeared.
3. **Jurisdiction and Notice:** Pursuant to Va. Code §§ 45.1-361.1 *et seq.*, and in particular Va. Code §§ 45.1-361.21 and 45.1-361.22, the Board finds that it has jurisdiction over the establishment and maintenance of an escrow account, with tract subaccounts, for each of the gas drilling units established by the Board that are subject to a Board pooling order. Further, the Unit Operator is required to deposit, as applicable, those funds specified in Va. Code § 45.1-361.21.D., into the applicable escrow tract subaccounts. The Board finds that it has the jurisdiction and authority to disburse funds from the Escrow Account when

previously unknown gas owners are identified and ownership issues are resolved by agreements and/or deed by and among all claimants owning gas estates in the tract in question or any undivided interest therein.

4. **Prior Proceedings:**

4.1. On July 3, 1997, the Board executed its order pooling all interests in the Subject Drilling Unit for the production of natural gas (herein "Gas") in accordance with the provisions of Va. Code §§ 45.1-361.21 (herein "Pooling Order"). The Pooling Order was filed with the Clerk of the Circuit Court of Tazewell County on July 15, 1997 in Deed Book 734 at Page 962. The Board designated Cabot Oil & Gas Corporation as the Unit Operator of the Subject Drilling Unit. The Pooling Order was amended and supplemented by the Board's Supplemental Order Regarding Elections executed on May 6, 1999 that was filed with the Clerk's Office on May 12, 1999 in Deed Book 773 at page 969 ("Supplemental Order") (hereafter the Pooling Order and the Supplemental Order are collectively referred to as the "Pooling Order").

4.2 To the extent owners of the Gas were unknown or unlocated pursuant to Va. Code § 45.1-361-21(D), payments attributable to said unknown or unlocated owners were ordered deposited by the Unit Operator into the escrow account established by the Pooling Order (herein "Escrow Account"). According to the Pooling Order, the oil and gas fee ownership of Charles David Sparks and Melinda Sparks Beavers and the unknown and unlocated heirs of Thomas J. and Thomas A. Belton in a 59.75-acre tract known as VGOB Plat Tract 4 and the oil and gas fee ownership of Melinda S. Beavers and Donald R. Beavers and the unknown and unlocated heirs of Thomas J. Belton and Thomas A. Belton in a 2.26-acre tract known as VGOB Tract 6, and the oil and gas fee ownership of Brockford, L. C., Alfred G. Waldron, Alfred G. Waldron Heirs, Betty Rose Waldron, Guyann Waldron Walker and the unknown and unlocated heirs of Thomas J. and Thomas A. Belton in a 9.74-acre tract known as VGOB Plat Tract 5 was unknown and any funds attributable to those tracts were subject to escrow.

4.3 The Unit Operator's Affidavit Regarding Escrow and Supplemental Order dated December 19, 2003, a copy of which is attached to and made a part hereof, and testimony given before the Board state under oath:

1. The heirs of Thomas J. and Thomas A. Belton have been located and identified;
2. Randy Ellis Asbury is attorney-in-fact representing the Belton Heirs in this matter, and, as such, was notified of the hearing;
3. Belton Heirs have conveyed any right, title and interest that they may have in and to Tracts 4, 5 and 6 to Charles David Sparks;
4. Alfred G. Waldron, Betty Rose Waldron Rhode and Guyann Waldron Walker have conveyed any right, title and interest that they may have

in and to Tract 5 to Charles David Sparks and Mary G. Sparks, his wife;

5. Brockford, L.C. has conveyed any right, title and interest that they may have in and to Tract 5 to Wendell Kent Brockman;
6. Donald R. Beavers has conveyed any right, title and interest that he may have in and to Tract 6 to Melinda S. Beavers;
7. By agreement, escrowed funds and future revenues from Tracts 4 and 6 are to be paid directly to Charles David Sparks (50%) and Melinda Sparks Beavers (50%).

4.4 The Unit Operator gave notice to Randy Ellis Asbury, Consolidation Coal Company, Charles David and Mary G. Sparks, Melinda Sparks Beavers and Wendell Kent Brockman that the Board would take the Affidavit referred to in Paragraph 4.3 above under consideration at its hearing on January 20, 2004 and consider whether to: (1) amend the Pooling Order to provide for the disbursement of funds on deposit in the Escrow Account attributable to Tracts 4, 5, and 6 and the interest of Charles David Sparks, Mary G. Sparks, Melinda Sparks Beavers and Wendell Kent Brockman in accordance with the terms of their agreement, (2) delete the requirement that the Unit Operator place future royalties attributable to Charles David Sparks, Mary G. Sparks, Melinda Sparks Beavers and Wendell Kent Brockman in Tracts 4, 5 and 6 in the Escrow Account, and (3) continue the escrow account under this docket number because parties other than those seeking disbursement under this order are subject to escrow.

4.5 The Unit Operator filed the attached accounting for Subject Drilling Unit's Escrow Account with the Board ("Accounting").

5. **Findings:**

5.1. Va. Code 45.1-361.22.5 provides:

The Board shall order payment of principal and accrued interests, less escrow account fees, from the escrow account to conflicting claimants within thirty days of receipt of notification of (i) a final decision of a court of competent jurisdiction adjudicating the ownership of coalbed methane gas as between them or (ii) an agreement among all claimants owning conflicting estates in the tract in question or any undivided interest therein. The amount to be paid to the conflicting claimants shall be determined based on the percentage of ownership interest of the conflicting claimants as shown in the operator's supplemental filing made part of the pooling order that established the escrow account, the operator's records of deposits attributable to those tracts for which funds are being requested, and the records of the escrow account for the coalbed methane gas drilling unit. The interests of any cotenants who have not entered into an agreement shall remain in the escrow account.

5.2 The Unit Operator has certified and represented to the Board that:

- (1) Charles David Sparks and Melinda Sparks Beavers are the owners of 100% of the oil and gas estate underlying VGOB Tracts 4 and 6 of the Subject Drilling Unit;
- (2) That Charles David Sparks and Melinda Sparks Beavers have entered into an agreement to split on a 50/50 basis royalties and escrowed funds attributable to gas underlying VGOB Tracts 4 and 6 of Subject Drilling Unit and their proportionate share of bonuses and/or royalties, if any, deposited by the Unit Operator in the Escrow Account which are attributable to said tract.
- (3) That the net interests attributable and to be disbursed to Charles David Sparks and Melinda Sparks Beavers in Tracts 4 and 6 are shown in Table 1, Below.

5.3 Amendments: Revised Exhibit C; Power of Attorney for Randall Asbury.

6. **Relief Granted:**

For the reasons set forth in Paragraph 4 and 5 above, and based upon the Accounting, the Escrow Agent is ordered to, within 10 days of receipt of this executed order: (1) disburse fifty percent (50%) of the funds attributable to VGOB Tracts 4 and 6, being 36.8668252 percent of funds on deposit in the escrow sub-account on the date of disbursement, to:

Exhibits C, D and F, as revised, to the Pooling Order, showing owners subject to escrow, are deleted in toto and replaced with the Revised Exhibits C, D and F attached to the Affidavit. Further, the Supplemental Order filed in this cause is hereby modified to delete the requirement that payments attributable to the gas ownership interests in VGOB Tracts 4 and 6 be deposited by the Unit Operator into the Escrow Account, and, because there are other owners subject to escrow under the Supplemental Order, the Escrow Agent is directed to continue the Escrow Account for Subject Drilling Unit . To the extent not specifically granted herein, any other or further relief is denied.

7. **Conclusion:**

Therefore, the requested relief and all terms and provisions set forth above in Paragraph 6 above be and hereby are granted and IT IS SO ORDERED.

8. **Appeals:**

Appeals of this Order are governed by the provisions of Va. Code § 45.1-361.9 which provides that any order or decision of the Board may be appealed to the appropriate circuit court and that whenever a coal owner, coal operator, gas owner, gas operator, or operator of a gas storage field certificated by the State Corporation Commission is a party in such action, the court shall hear such appeal de novo.

9. **Effective Date:** This Order shall be effective as of the date of the Board's approval of this Application, which is set forth at Paragraph 1 above.
