REPORT OF BOARD

FINDINGS AND ORDER

This Supplemental Order is entered by the Board *sua sponte* in the form authorized by the Board at hearings held on February 15, 1994 and June 16, 1992; and this Supplemental Order is being recorded for the purpose of supplementing the Orders previously entered in the captioned matter on January 21, 2000, which was recorded at Deed Book 767, Page 152 in the Office of the Clerk of the Circuit Court of Tazewell County, Virginia, on January 27, 2000, and entered on October 5, 1999, which was recorded at Deed Book 783, Page 753 in the Office of the Clerk of the Circuit Court of Tazewell County, Virginia, on October 14, 1999, (herein "Board Order or Orders") and completing the record regarding elections.

Findings: The Board finds that:

The Board Order directed POCAHONTAS GAS PARTNERSHIP (herein "Designated Operator") to mail copies of the Board Order to all Respondents whose interests, if any, were pooled by the said Board Order;

The Designated Operator filed its affidavit of elections disclosing that it had mailed a true and correct copy of the Board's Order to all Respondents whose interests, if any, were pooled by said Board Order;

The Board Order required each Respondent whose interests, if any, were pooled by the terms of said Board Order to make an election within thirty (30) days after the date of mailing or recording, as applicable, of said Order; the affidavit of elections filed herein and annexed hereto as Exhibit A states: (i) whether each Respondent has made or failed to make a timely election; (ii) the nature of any election(s) made; and (iii) whether, by reason of a failure to elect or to timely elect one or more Respondents are deemed, under the terms of the Board's Order, to have leased all their rights, title, interests, estates and claims in Subject Drilling Unit to the Applicant;

The affidavit of elections annexed hereto and the Exhibits submitted therewith identify the Respondent(s) making a timely election, if any; identify the Respondent(s), if any, who are deemed to have leased; identify the conflicting interests and claims, if any, which require escrow; identify the interests and claims, if any, requiring escrow under Virginia Code section 45.1-361.21.D.; identify the Respondents, if any, who may be dismissed by reason of having leased or entered into a voluntary agreement with the Applicant; and identify the conflicting owners/claimants with royalty split agreements.

The affidavit of elections indicates that the escrow of funds is required with regard to Unit W-47.

Order: By this Order, the Board (1) orders the Designated Operator to tender, consistent with and in accordance with the findings set forth at paragraph 2 above and the annexed affidavit of elections and Exhibits thereto, any funds subject to escrow, (2) orders the Escrow Agent, First Union National Bank, Corporate Trust PA 1328, 123 South Broad Street, Philadelphia, PA 19109-1199, or any successor named by the Board to establish interest bearing escrow account(s) for each tract identified in Exhibit E to the Affidavit of Elections, IRS Tax Identification Number 54-1629506, and in accordance with the Board's prior Orders made herein, and to receive tendered funds and account to the Board therefore, and (3) orders the Designated Operator to pay royalties directly

owners/claimants with royalty split agreements identified in Exhibit EE to the Affidavit of Elections in accordance with their agreement(s).

Mailing of Order and Filing of Affidavit: The Designated Operator under the captioned Order or shall file an affidavit with the Secretary of the Board within ten (10) days after the date of receipt of this Order stating that a true and correct copy of this Order was mailed to each Respondent whose interests or claims are subject to escrow and whose address is known within seven (7) days from the date of receipt of this Order.

Conclusion: Therefore, the findings and all terms and provisions set forth above be and hereby are granted and IT IS SO ORDERED.

Effective Date: This Order shall be effective on the date of its execution.






