
REPORT OF BOARD

FINDINGS AND ORDER

1. The Board enters this order to correct a scrivener's error contained in Exhibit B to that certain Supplemental Order Regarding Elections, Unit VC-3614 entered by the Board on April 26, 2001 and filed with the Circuit Court of Dickenson County, VA on May 1, 2001 at Deed Book 364 at Page 124 (herein "Supplemental Order").
2. Findings: The Board finds that:
 - a. By order issued by the Board for subject Docket on May 15, 2000 and recorded at Book 354, Page 660 in the Office of the Clerk of the Circuit Court, Dickenson County, Virginia on May 17, 2000 ("Pooling Order"), the Board pooled all the rights, interests and estates in and to the Coalbed Methane Gas in the drilling unit served by Well VC-3614 ("Subject Drilling Unit"), including those of the respondents set forth in Exhibit B thereto.
 - b. The Pooling Order named Equitable Production Company as the operator of Subject Drilling Unit ("Unit Operator").
 - c. To complete the record regarding the elections made by Respondents in accordance with the terms of the Pooling Order, the Board entered the Supplemental Order.
 - d. By Affidavit of Mailing (Certificate of Service) executed in behalf of the Unit Operator of August 22, 2001, a copy of which is attached hereto and made a part hereof, the Unit Operator (1) advised the Board that the Exhibit B attached to and made a part of the Supplemental Order contained a scrivener's error in that it failed to reflect the net revenue interest (NRI) for each respondent, and (2) provided to the Board a corrected Exhibit B.

- 3. Order: By this Order, The Board corrects the scrivener's error in Exhibit B-3 to the Supplemental by hereby deleting said Exhibit in toto and substituting in its place the Exhibit B attached hereto and made a part hereof.
- 4. Mailing of Order and Filing of Affidavit: The Unit Operator or its Attorney shall file an affidavit with the Secretary of the Board within ten (10) days after the date of receipt of this Order stating that true and correct copy of this Order has been sent to each unleased or deemed lease person named in Exhibit B hereto whose address is known.
- 5. Conclusion: Therefore, the findings and all terms and provisions set forth above be and hereby are granted and IT IS SO ORDERED.
- 6. Effective Date: This Order shall be effective as of April 26, 2001, the date the Supplemental Order was entered by the Board.
