REPORT OF BOARD

FINDINGS AND ORDER

This Supplemental Order is entered by the Board *sua sponte* in the form authorized by the Board at hearings held on February 15, 1994 and June 16, 1992; and this Supplemental Order is being recorded for the purpose of modifying and supplementing the Order previously in the captioned matter on April 15, 2002 which was recorded at Deed Book 545, Page 185 in the Office of the Clerk of the Circuit Court of Buchanan County, Virginia, on April 22, 2002, and completing the record regarding elections.



Conclusion: Therefore, the findings and all terms and provisions set forth above be and hereby are granted and IT IS SO ORDERED.


