

REPORT OF BOARD


FINDINGS AND ORDER

1. The Board enters this order to correct scrivener's errors contained in that certain "Report of the Board - Findings and Order", recorded in the office of the Clerk of the Circuit Court, Buchanan County, Virginia on November 17, 2006 as Instrument 060003842 and affecting Coalbed Methane gas unit G-9 located in Oakwood I Coalbed Methane Gas Field, South Grundy District, Buchanan County, Virginia (herein "Subject Drilling Unit"). Said recorded orders pooled the interests of unleased parties in the unit.
2. Findings: The Board finds that:
 - (a) By order issued by the Board for subject docket on November 15, 2006 and recorded as instrument 060003842 in the office of the Clerk of the Circuit Court, Buchanan County, Virginia, the Board pooled unleased interests in the unit (herein "Pooling Order").
 - (b) The Pooling Order named CNX Gas Company, LLC as the operator of Subject Drilling Unit.
 - (c) The Pooling Order provided pooled parties with leasing and participation options.
 - (d) It has come to the attention of the Board staff that there were scrivener's errors in the Pooling Order, to wit, statements on Exhibit B-3 as follows: "Note: (Mr. McGlothlin owns a total of 5/6 interest, but 76/509 was leased before it was purchased)"
3. Order: By this Order, The Board corrects the following scrivener's errors in the Pooling Order:
 - (a) A corrected Exhibit B-3 is attached hereto and made a part of the Pooling Order for Docket Number 06-0718-1667.
 - (b) The statement quoted in 2(d) above is deleted and replaced by the following corrected statement: "Note: (Mr. McGlothlin owns a total of 100% of the oil, gas and CBM, but 31.5952% was leased before purchase)".
4. Mailing of Order and Filing of Affidavit: The Unit Operator or its Attorney shall fill an affidavit with the secretary of the Board within ten (10) days after the date of receipt of this Order stating that a true and correct copy of this Order has been sent to each person whose interest or claim is subject to pooling or escrow and whose address is known.
5. Conclusion: Therefore, the findings and all terms and provisions set forth above be and hereby are granted and IT IS SO ORDERED.
6. Effective date: This order shall be effective as of September 19, 2006, the date Pooling Order was approved by the Board.




