Virtex Eastern Producing Company, LLC, petitioned the Virginia Gas & Oil Board for an order transferring to it the right to operate all of the well units noted in Exhibit G of its petition from Dart Oil & Gas Corporation. Virtex Eastern Producing Company, LLC, was represented by counsel at the hearing on the petition.

The petition is attached hereto and, for the exhibits referenced, is incorporated into this order.




