NOTE: Persons planning to attend any of these classes must:

- ❖ Have received a letter from DMM, indicating it is time for renewal (within six months of the expiration date on the certificate) and
- ❖ Submit completed & signed Application for Renewal (DMM-BMME-3), Verification of Work Experience (DMM-BMME-2) forms, and copy of current first aid card, along with the **\$10 application fee**. The person must show on the DMM-BMME-2 that they have worked **at least 24 months of the last 5 years** within the capacity of the certificate held; if not meeting the work experience requirement, the class is not a renewal option. Forms & fees must be received **5 BUSINESS DAYS** prior to class date.
