An objection has been filed by the Coal Owner and a Royalty Owner against the permit application for **CNX Gas Company LLC. Gas Operations CBM N75A well with pipeline** in accordance with:

**Rapoca Coal Company Objection: referencing § 45.1-361.35** as follows:

- 4. The Location of the coalbed methane well or coalbed methane well pipeline will unreasonably infringe on the surface owner's use of the surface, provided, however, that a reasonable alternative site is available within the unit, granting the objection will not materially impair any right contained in an agreement, valid at the time of the objection, between the surface owner and the operator or their predecessors or successors in interest.*

**ELE LLC Objection: referencing § 45.1-361.35 (C1)** as follows:

*C. The only objections to permits or permit modifications which may be raised by royalty owners are whether the proposed well work:*

- 1. Directly impinges upon the royalty owner's gas and oil interest;*

All testimony in this conference must be relevant to objections allowed for and detailed in the Gas and Oil Act.
