**NOTICE OF
INFORMAL FACT FINDING HEARING (IFFH)**

**In regard to Nora Gathering, LLC
Proposed Permit for New Gas Operation**

Application 16086 for Gas Well Pipeline VCI-539532 PL

Located in the Kenady District of Dickenson County, Virginia

Docket Number IFFH 24007

In Accordance with §45.1-361.35.H. of the Code of Virginia, the Director of the Division of Gas and Oil has scheduled an Informal Fact Finding Hearing to consider objections received from **Michael Hamilton** to be affected by the above-named operation(s). The **objections by the Surface Owners were** received at the Division of Gas and Oil Office in a timely manner and in accordance with § 45.1-361.35. This notice of hearing is being sent to the permit applicant and to all parties with standing to object as prescribed by §45.1-361.30. All parties are entitled to be represented by counsel at the hearing, if desired. Those receiving notice of this proceeding and who did not object to the application are not required to attend.

The objections have been filed by the Surface Owners against the permit applications for **Nora Gathering, LLC Gas Well Pipeline VCI-539532 PL** in accordance with:

§ 45.1-361.35. Objections to permits; hearing.

B. The only objections to permits or permit modifications which may be raised by surface owners are:

- 1. The operations plan for soil erosion and sediment control is not adequate or not effective;*
- 2. Measures in addition to the requirement for a well's water-protection string are necessary to protect fresh water-bearing strata;*
- 4. Location of the coalbed methane well or coalbed methane well pipeline will unreasonably infringe on the surface owner's use of the surface, provided, however, that a reasonable alternative site is available within the unit, and granting the objection will not materially impair any right contained in an agreement, valid at the time of the objection, between the surface owner and the operator or their predecessors or successors in interest.*

All testimony in this conference must be relevant to objections allowed for and detailed in the Gas and Oil Act of 1990.

Date and location of Conference:

The hearing is scheduled for Thursday, May 13, 2010 beginning at 1:15 pm. The hearing will be held in a conference room at the Department of Mines Minerals and Energy, Division of Gas and Oil, Russell County Government Center, 135 Highland Drive, Lebanon, Virginia.
